Federal Appellate Cases

- Won affirmance of nearly \$60 million judgment for our client, a Fortune 500 company, in appeal to the U.S. Court of Appeals for the Fifth Circuit

State Appellate Cases

- Successfully represented client on a securities law issue of first impression before the Georgia Court of Appeals and the Supreme Court of Georgia and obtained a unanimous decision in client's favor from the Supreme Court—resulting in dismissal of claims for nearly \$200 million in damages
- Petitioned for certiorari to the Georgia Supreme Court and obtained expedited ruling that the Court of Appeals had improperly denied our client's motion for a stay pending appeal of trial court's order disqualifying a major international law firm
- Successfully argued in the Georgia Supreme Court on behalf of Georgia's Attorney General in a suit brought by the Governor seeking to compel the Attorney General to dismiss an appeal pending in the U.S. Supreme Court
- Convinced the Georgia Court of Appeals to reverse trial court's certification of state-wide consumer class action against a pest control company
- Secured affirmance by the Georgia Court of Appeals of \$28 million fee awarded to class counsel in lawsuit brought by retired educators regarding underpayment of retirement benefits
- Briefed numerous successful applications for interlocutory appeal to the Georgia Court of Appeals as well as successful petition for certiorari following denial of application for interlocutory appeal
